 - Law.** You also need LED's four law texts for 2021 – juvenile, motor vehicle, criminal procedure, and criminal law – and the corresponding “Q books,” which provide 4,000 questions to get you tuned up on law! Listen to Police Administration (PA). Listen to about 1.25 hours of PA lecture per day. 7½ hours (with an extra 30 minutes if you are a Lt. or Capt. candidate). The study skills section is repeated in the beginning of PA. Listen again! • Re-read your underlining and go over things you didn't absorb from the lectures. 6 hours.
2	July 4 - 10	<ul style="list-style-type: none"> • Audio Class! Listen to Community Policing (CP). Listen to 1 hour of CP lecture per day. 7 hours. • Re-read your underlining and go over things you didn't absorb from the lectures. 4 hours. • Management Q! PA questions. Do ½ of the PA questions (about 250). Look up the ones you got wrong. Go into the book and come up with your own potential questions. Really work this learning process! This active studying pays great dividends. Notice how we separate your audio lectures on a book from the week you do practice questions. This reinforces long-term recall for the exam! 5 hours.

3	July 11 - 17	<ul style="list-style-type: none"> • Audio Class! Listen to Criminal Investigation (CI). Listen to 1 hour of CI lecture per day. <i>7 hours.</i> • Management Q! PA questions. Do other ½ of PA questions. Use our look-up process! <i>5 hours.</i> • Management Q! CP questions. Do ½ of CP questions (about 200). This is a new book. If it's your first exam, this is where you score! <i>7 hours.</i> ○ Lts. and Cpts. listen to Iannone's Supervision of Police Personnel (SPP). Listen to 1 hour of SPP per day. <i>7 hours.</i> • Re-read your underlining and go over things you didn't absorb from the lectures. <i>4 hours.</i> • Management Q! CP questions. Do other ½ of CP questions. Use our look-up process! <i>5 hours.</i>
5	July 25 - July 31	<ul style="list-style-type: none"> • Audio Law! Listen to Juvenile Law (JUV). Listen to 1½ hours of JUV lecture per day. This is Priority 1 for law topics. <i>10 hours.</i> • Management Q! CI questions. Do <u>all</u> CI questions (600). Use our look-up process! This is it for Criminal Investigation, so make it count! <i>6 hours.</i>
6	August 1 - 7	<ul style="list-style-type: none"> • Audio Law! Listen to Motor Vehicle Law (MV). Listen to 1¼ hours of MV lecture per day. This is law Priority 2. <i>7½ hours.</i> • Juvenile Q! JUV questions. Do <u>all</u> questions (800). Use our look-up process! Work it. <i>8 hours.</i>
7	August 8 - 14	<ul style="list-style-type: none"> • Audio Law! Listen to Combo Criminal Procedure & Law (PRO/LAW). Listen to 2 hours of lecture per day. This is law Priority 3. <i>15 hours.</i> <i>Note:</i> Little bit easier week. Take a break. Or use time to catch up on questions, review text underlining, etc.
8	August 15 - 21	<ul style="list-style-type: none"> • Re-mix Audio! Listen to Police Administration (PA) again. 1.25 hrs. of PA lecture per day. <i>7½ hours</i> (with an extra 30 minutes if you are a Lt. or Capt. candidate). You will be giving the lecture before I do! Cement the key issues and pick up new stuff! • Motor Vehicle Q! MV questions. Do <u>all</u> questions (1,000). Use our look-up process! Work it. To save time, you can focus on questions from the priority chapters first. <i>7 hours.</i>
9	August 22 - 28	<ul style="list-style-type: none"> • Management Q! Sergeants do ES questions. Lts and Cpts do SPP questions. Sergeants do <u>all</u> ES questions (350). Lts. and Cpts. do <u>all</u> SPP questions (400). Use our look-up process! These books are key. <i>5 hours.</i> • Re-mix Audio! Listen to Community Policing (CP) again. Listen to 1 hour of CP lecture per day. <i>7 hours.</i> Work it! • Criminal Procedure Q! PRO questions. Do ½ of questions (500). Use our look-up process! To save time, you can focus on questions from the priority chapters. <i>4 hours.</i>

Listen to 1 hour of ES per day. 7 hours. ○ Lts. and Cpts. listen to Iannone's Supervision of Police Personnel (SPP) again. Listen to 1 hr. of SPP per day. 7 hours. • Criminal Procedure Q! PRO questions. Do other ½ of questions (500). Use our look-up process! To save time, you can focus on questions from the priority chapters. 5 hours. • Criminal Law Q! LAW questions. Do select questions from priority law chapters (about 450). Use our look-up process! 4 hours.
11	September 5 - 11	<ul style="list-style-type: none"> • Review "black letter law" and underlining in JUV, MV, PRO, and LAW manuals in priority chapters. 9 hours. • Review underlining in top 6 priority chapters for each assigned management text — PA, CP, CI, and ES (Sgts.) or SPP (Lts. & Cpts.). 9 hours. • Note: Last big week of study! You are really cementing your knowledge as you go through the entire set of materials!
12	September 12 - 17	<ul style="list-style-type: none"> • Freestyle! Listen to an audio class of your choice or re-do practice questions in management and/or law. 8 to 9 hours. • NO STUDYING on the 17th — the day before the exam. Absolutely none. Let your brain relax. You are ready . . .
